THE TRADING AREA WILL BE OPENED AT 9.00am ON FRIDAY 10th JULY 2020 FOR SET-UP (Traders may arrive on Thursday 9th July ONLY if pre-arranged with the organisers).
SHOW OPENS AT 12 NOON ON FRIDAY - STANDARD STALLS WILL BE ABLE TO TRADE UPTO 11.30pm ON FRIDAY AND SATURDAY THIS YEAR BUT CATERERS CAN
STAY OPEN LATER IF THEY WISH TO CATCH TRADE DURING/AFTER THE EVENINGS ENTERTAINMENT. THE SHOW WILL END AROUND 4.00PM ON SUNDAY 12TH
JULY 2020. TRADERS MAY STAY OVER ON SUNDAY NIGHT (by arrangement only) AND LEAVE MONDAY MORNING BY 11.00AM IF THEY LIKE.

Any trader using a Trade Pass for any other reason than entry for trading will be asked to leave the site immediately. All trade stands will be sited by the organisers. Unless otherwise agreed with the organisers ALL trade stands will have a frontage width of 5 metres. Trading legislation - the applying of companies' names, trademarks and logos or supplying goods without consent or authorisation is an offence under the Trade Description Act. Traders must comply with ALL trading legislation. The show organisers will NOT be held responsible for any breaches of trading laws. Traders are NOT allowed to sub-let any part of the trading area they have been allocated. At the end of the show traders MUST clear all litter from their trade pitch and will be charged for any rubbish removal if they fail to do so. Traders who supply their own electrical generators on-site must ensure it is kept in an area which is secure and away from the general public - any fuel used should be contained safely and suitable fire extinguishing equipment be in place in the event of an emergency. Petrol driven generators are NOT advised - diesel is preferred. Traders are required to ensure they are suitably insured - including fire and all other risks and including third party liability and public liability. Traders must also indemnify the show organisers against all claims, damages or expense whatsoever in any way arising out of their attendance or property at the show. The completed booking form shall be deemed as confirmation by the trader that the necessary insurance cover has been obtained and the trader agrees to indemnify the show organisers and their staff of any claims which may arise. The show organisers will not be liable for any theft, loss, damage under any circumstances to any property/goods etc. belonging to the trader. The trader shall NOT cause noise, disturbance or annoyance to any other trader or show exhibitor or any member of the general public and under no circumstances shall the trader display or sell any of the following... Chinese style sky lanterns, any food or refreshments (unless trading as an approved caterer) including alcohol, cigarettes and tobacco... any photographic equipment including films... any knives, crossbows/catatapults, offensive weapons or firearms of any type including air powered or 'BB' type of guns... any legal OR illegal drugs... any product that may bring into question the reputation or good will of the show and/or it's organisers and staff. No promoting or advertising of other events is allowed unless prior written agreement is obtained from the Summerfest show organisers. All quads, mini-motos or any other unlicensed vehicles/bikes are banned from use on site and any trader found to be taking part or encouraging such use will be asked to leave the site without any refunds for any fees paid etc. Although on site security will be in operation, traders are solely responsible for the safe keeping of all goods/items and equipment etc. on their own stands. The event organisers will NOT be responsible in any way for the loss or damage to traders/exhibitors property or vehicles whilst on site at Summerfest. In the event of cancellation any deposit/fees paid to the organisers will be forfeited. Summerfest organisers and staff reserve the right to refuse entry or remove any trader/exhibitor without prior notice. As from July 2007, smoking was prohibited in virtually all enclosed public places and this includes tents, marquees and some other shelters - traders/exhibitors must comply with this law. The organisers decision in ANY dispute is final and binding.
